Asia-Pacific Structured Finance Association (APSA): Susie Cheung is a Founding Member and Co-Convenor of APSA which was established in 2006. As a former Director of the Board and an Executive Secretary-General of the China Securitisation Forum (CSF), Susie has over the years been involved in promoting cross-border securitisation between Mainland China and Hong Kong.

CUHK Medical Centre (CUHKMC) and CUHK Faculty of Medicine: Susie was the former Chief Legal Counsel and Company Secretary of the CUHKMC. She participated in the planning, establishment and commissioning of the hospital; advised on the implementation of corporate governance for the Boards and Committees of the CUHKMC Group of Companies; and the adoption of standardised commercial contracts for the hospital. Susie is currently an Adjunct Professor of the CUHK Faculty of Medicine.

Hong Kong Mortgage Corporation (HKMC): Prior to her joining the CUHKMC, Susie was the former General Counsel and Company Secretary of the HKMC, a corporation owned by the Exchange Fund of the Hong Kong SAR under the supervision of the Hong Kong Monetary Authority (HKMA), for 19 years since its inception in 1997. Susie made significant contributions to the development of the local debt and mortgage-backed securities markets in Hong Kong during her term as its General Counsel.

Professional and Academic Qualifications: Susie is qualified as a Solicitor of the Supreme Court of England and Wales, and also the High Court of the Hong Kong SAR. Susie obtained her LL. B and LL.M from **University College London**. She is a Fellow of the Hong Kong Chartered Governance Institute and the Institute of Directors respectively.

Commendation/Award: Susie was honoured to have served as Company Secretary under **4** successive Financial Secretaries of Hong Kong who, ex officio, acted as Chairman of the Board of the HKMC, and **2** successive Chief Executives of the HKMA who acted as its Deputy Chairman. In his commendation letter, the Financial Secretary as Chairman commended the contributions made by Susie towards the “*HKMC’s strong corporate governance and strong compliance*”.

Susie received the “**Outstanding Achievement - Asia Women in Business Law Awards 2012**” in recognition of the contributions which she had made to the debt and securitisation markets in Hong Kong, and the introduction of legal counselling and the strong risk disclosure measures for the protection of the elderly borrowers which she initiated under the *Reverse Mortgage Programme (安老按揭)* in Hong Kong.
