#### Membership Information

#### Membership:

Under the Memorandum and Articles of Association and the Rules of the APSA, there are three classes of membership:

#### 1. Corporate Membership

Corporate membership is open to any corporation, firm, association, partnership or organisation which participates in or has an interest in the financial markets and structured finance and is willing to abide by the objects, articles and rules of the APSA. To apply to become a Corporate Member, an applicant should submit to the APSA a completed application form together with relevant supporting documents and nominate in writing up to two representatives authorised to represent such Corporate Member at any one time.

An applicant shall become a Corporate Member when its application is approved by the Executive Committee and the prescribed fees are paid.

#### 2. Individual Membership

Individual membership is open to any individual who participates in or has an interest in the financial markets and structured finance and is willing to abide by the objects, articles and rules of the APSA. To apply to become an Individual Member, an applicant should submit to the APSA a completed form together with relevant supporting documents.

Individual members may apply for annual membership or life membership.

An applicant shall become an Individual Member when his application is approved by the Executive Committee and the prescribed fees are paid.

#### 3. Student Membership

Student membership is open to any individual who is in full-time education at a recognised institution and is willing to abide by the objects, articles and rules of the APSA. To apply to become a Student Member, an applicant should submit to the APSA a completed form together with relevant support documents.

An applicant shall become a Student Member when his application is approved by the Executive Committee and the prescribed fees are paid.

**Fees:**

1. The current membership fees of APSA are as follows:
  - (a) Corporate Membership : HK\$6,000 per annum;
  - (b) Individual Membership : HK\$800 per annum OR HK\$5,000 for life membership;
  - (c) Student Membership : HK\$100 per annum.

APSA's current membership year now runs from 1 January to 31 December.
