Membership Information

Membership:

Under the Memorandum and Articles of Association and the Rules of the APSA, there are three classes of membership:

1. Corporate Membership

Corporate membership is open to any corporation, firm, association, partnership or organisation which participates in or has an interest in the financial markets and structured finance and is willing to abide by the objects, articles and rules of the APSA. To apply to become a Corporate Member, an applicant should submit to the APSA a completed application form together with relevant supporting documents and nominate in writing up to two representatives authorised to represent such Corporate Member at any one time.

An applicant shall become a Corporate Member when its application is approved by the Executive Committee and the prescribed fees are paid.

2. Individual Membership

Individual membership is open to any individual who participates in or has an interest in the financial markets and structured finance and is willing to abide by the objects, articles and rules of the APSA. To apply to become an Individual Member, an applicant should submit to the APSA a completed form together with relevant supporting documents.

An applicant shall become an Individual Member when his application is approved by the Executive Committee and the prescribed fees are paid.

3. Student Membership

Student membership is open to any individual who is in full-time education at a recognised institution and is willing to abide by the objects, articles and rules of the APSA. To apply to become a Student Member, an applicant should submit to the APSA a completed form together with relevant support documents.

An applicant shall become a Student Member when his application is approved by the Executive Committee and the prescribed fees are paid.

Fees:

1. The annual membership fee to be paid by members in respect of each 12-month membership period shall be determined by the Executive Committee in advance of that period. Unsuccessful applicants will have the membership fee returned to them.
2. The current membership fees of APSA are as follows:
 - (i) Corporate Membership : HK\$4,000 per annum;
 - (ii) Individual Membership : HK\$500 per annum; and
 - (iii) Student Membership : HK\$100 per annum.

APSA's current membership year runs from 1 July to 30 June the following year.

Notes:

2. Please send the completed application form, a cheque for the appropriate annual membership fee drawn in favour of "**The Asia-Pacific Structured Finance Association Limited**" together with the following:
 - (i) For corporate membership, please send a copy of the business registration certificate and business cards.
 - (ii) For individual membership, please send a copy of your business card.
 - (iii) For student membership, please send a copy of evidence of full-time studies (including when the course is expected to complete).

3. Each member shall be obliged to:
 - (i) abide by the objects, articles and rules of the APSA and the resolutions passed by the Executive Committee, Annual General Meetings and Extraordinary General Meetings; and
 - (ii) pay any fees promptly as and when they fall due, including annual membership fee in advance for each 12-month membership period.
4. The Executive Committee of the APSA has the sole discretion to accept or decline applications for membership without providing any reasons.
